NOTICE IS HEREBY GIVEN that the Annual General Meeting of Northern Credit Union Limited will be held on Friday, April 17, 2020 at 3:00 pm at Quattro Hotel & Conference Centre, 229 Great Northern Road, Sault Ste. Marie, ON for the following purposes:

- TO RECEIVE REPORTS INCLUDING THE FINANCIAL STATEMENTS FOR THE FISCAL YEAR ENDING DECEMBER 31, 2019
- TO APPOINT THE EXTERNAL AUDITOR
- TO TRANSACT SUCH OTHER BUSINESS AS MAY BE PROPERLY BROUGHT BEFORE THE MEETING

### SPECIAL BUSINESS WILL BE CONDUCTED IN ADVANCE OF THE AGM AS FOLLOWS:

All eligible Members of Northern Credit Union shall be permitted to cast their ballots using any one of the following methods, but each Member shall select only one of the following methods and can cast only one ballot:

- In-branch electronic voting at any branch or administrative office of the Credit Union
- Electronic voting from any other personal device. The electronic voting will be conducted through the secure platform called eVote. The link to eVote can be found on Northern's website. Step-by-step instructions have been provided on the website. Members will require their member number and birth date in order to access the voting platform.
- The voting period will open on **March 23, 2020 at 12:00am** and close on **April 3, 2020 at 12:00pm**. Please note that in-branch electronic voting at any branch or administrative office of the Credit Union will only be available during the usual business hours of that branch or office.

### THE BUSINESS TO BE CONDUCTED VIA ELECTRONIC VOTING IS AS FOLLOWS:

- **TO ELECT FIVE (5) DIRECTORS TO NORTHERN CREDIT UNION'S BOARD OF DIRECTORS** – for 4 - 3 year terms and 1 – 1 year term. Director nominees are: Louise Ahrens, Kyle Cormier, Jeannie Kilgour, Suzanne Klatt, George Lowes, Lori Martin, Daniel McCoy, Martin Poirier, Cameron Ross
- **TO APPROVE A BY-LAW TO AMEND THE BY-LAWS OF NORTHERN CREDIT UNION LIMITED.**  
**Key changes are:**
  - Changes to deal with minor housekeeping issues – includes amendments to 2.09, 4.11, 4.15
  - Changes under "Qualifications for Directors" to run for the Board – includes amendments to 4.02(b), 4.02(c), 4.02(d), 4.02(e), 4.02(f)
  - Changes under "Nominations" to reflect current practice – includes amendment to 5.05
  - Changes to "Election Process" to provide better clarity as it relates to the election process – includes amendments to 7.05, 7.11, 7.13(a), 7.13(i)(i)
